THE GROUNDWATER PLUME HAS BEEN DELINEATED AND NO FURTHER SUBSURFACE INVESTIGATION IS REQUIRED AT THE SITE. LAB ANALYTICAL RESULTS FROM GROUNDWATER AND SOIL SAMPLES THAT WERE COLLECTED DURING EXCAVATION AND GEOPROBING ACTIVITIES INDICATE THAT MODERATE HYDROCARBON IMPACTS EXIST OUTSIDE THE EXTENT OF THE PREVIOUS EXCAVATION. Groundwater monitoring will continue on a quarterly basis at the eight site monitoring wells (BH01R-BH03R and BH07-BH11). Groundwater samples will be submitted for laboratory analysis of benzene, toluene, ethylbenzene, total xylenes (BTEX), naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB by EPA Method 8260B in accordance with Table 915-1. Per the approved Supplemental Form 27 (Document No. 402813354), analysis of total dissolved solids (TDS), and chloride and sulfate anions have been removed from the quarterly sampling plan following the third quarter 2021 groundwater monitoring event. Quarterly groundwater monitoring will continue until closure criteria is achieved.
