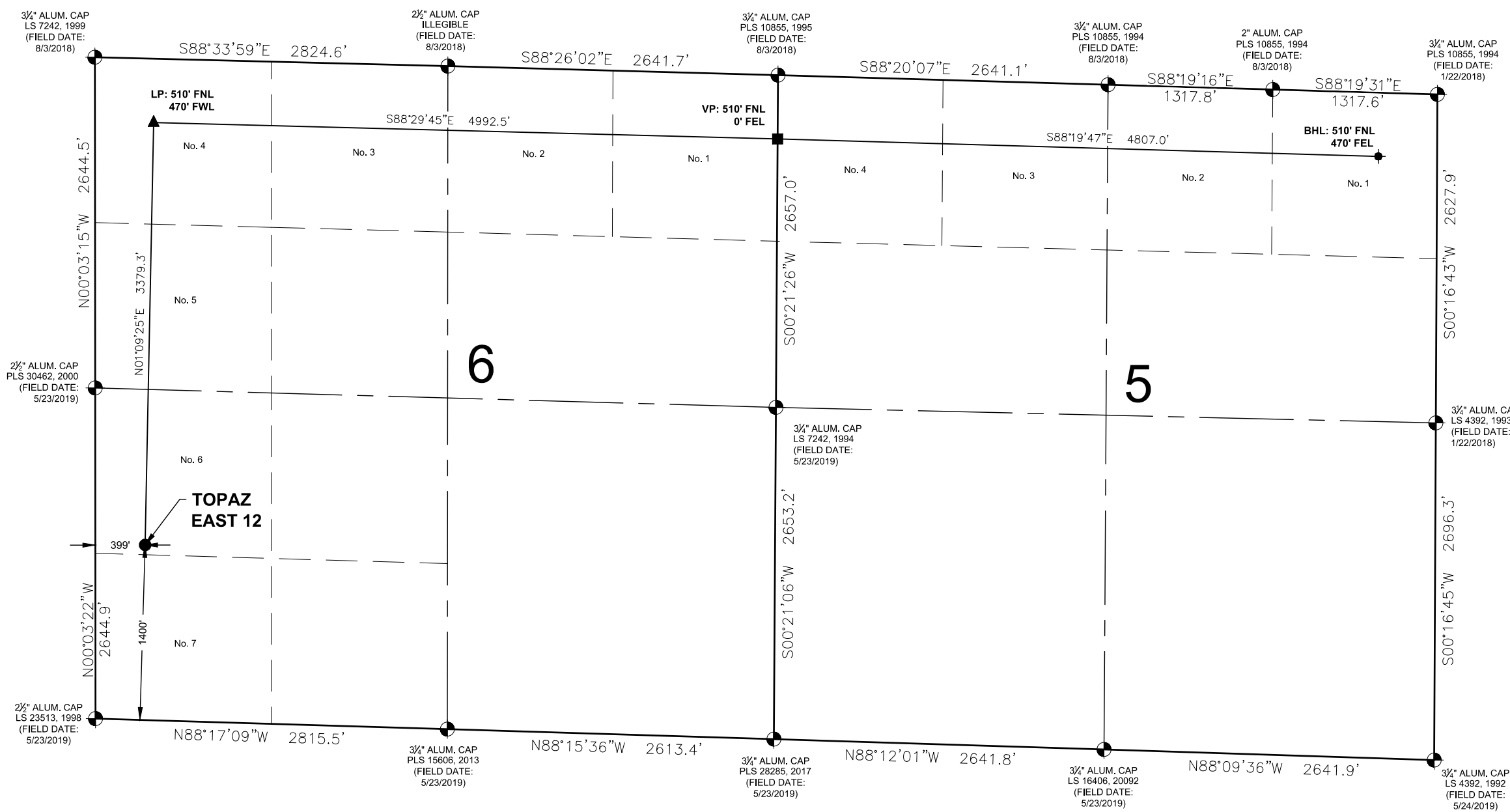


TOPAZ EAST 12

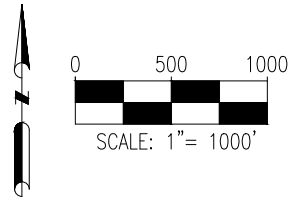
