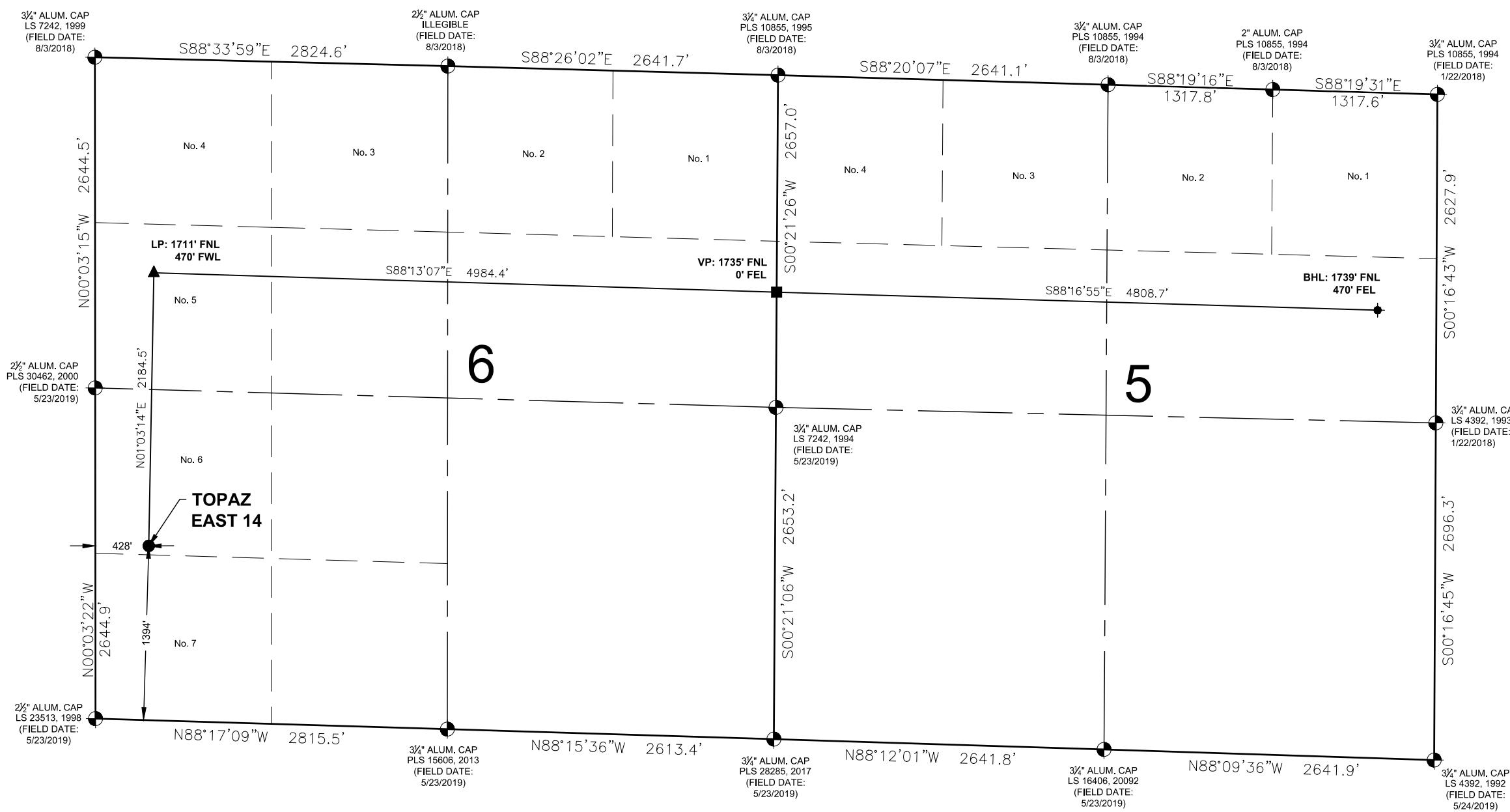


TOPAZ EAST 14

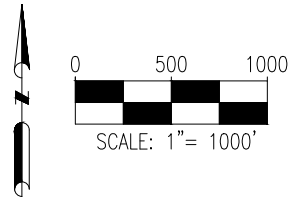
