While there, I observed incomplete placards on the produced water tank, trash and unused equipment around location. During this inspection the following possible compliance issues were observed: Rule 605.h. with a corrective action date of 1/31/2022, Rule 606. with a corrective action date of 1/31/2022. A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
