Comment	<p><u>Interim reclamation areas appear to have degraded since the previous inspection. Interim reclamation areas appear to have a higher abundance of cheatgrass than the previous inspection and a List C Colorado noxious weed, Puncture vine, was observed throughout portions of the interim area. Refer to the attached inspection photo.</u></p> <p><u>It appears interim reclamation areas have been recently grazed, which could have contributed to the degradation. Operator may need to consult with the surface owner on grazing practices within the interim reclamation area. The immediate reference areas appear to be overgrazed and have a high abundance of cheatgrass.</u></p> <p><u>Operator should consider additional reclamation activities for Spring 2022.</u></p>
