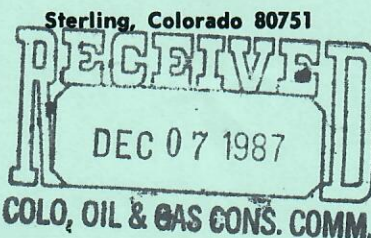

| 6-22-87 | 0 hours | Moved unit in. Raised pole. |
| 6-23-87 | 0 hours | Dug two deadmen. Dug pit. Pulled 200 rods. |
| 6-24-87 | 0 hours | Pulled 50 rods and tubing. |
| 6-25-87 | 0 hours | Dug cellar. Ran sand. Loaded hole. Set in floor. Worked pipe to 9". |
| 6-30-87 | 0 hours | Set 5 sacks cement on sand. Ran 10 joints 1" tubing. Pumped 30 bbls. water. Pulled tubing. Shot 2 holes at 1800'. Pumped 30 bbls. oil and 45 bbls. water. Vacuum truck, hauled oil, 4 hours. |
| 7-01-87 | 0 hours | Worked pipe to 12". Tore down. |
| 8-19-87 | 0 hours | Moved rig on well. Dug cellar. Raised mast. Set in floor. |
| 8-20-87 | 0 hours | Worked pipe to 17". Ran 45 joints tubing. |
| 8-21-87 | 0 hours | Ran 15 joints spotting tubing, total 60 joints. Pumped 2 loads mud and 33 bbls. oil. Vacuum truck hauled 25 bbls. & 8 bbls. from treater. Vacuum pumped from mud pits into big pit. Vacuum Truck, 7 hours. |
| 8-24-87 | 0 hours | Worked casing to 53". Pushed plug to bottom. |
| 8-25-87 | 0 hours | Worked pipe. Ran a shot to 5200'. Worked pipe loose. Pulled 80 joints. |
