The following are descriptions perforate and squeeze plugs with Tag requirements.

Plug #2 - Perf at 6900' and 6800', set CICR at 6810' and pump 35 sx through CICR. Leave 10 sx on top of CICR.

Plug #3 - Perf at 2630' and pump 40 sx through perfs. Leave 10 sx inside. Tag above 2530' is required.

Plug #4 - Place 50 sx balanced plug from 1734'. Tag above 1333' is required.

Plug #5/Surface - Place 110 sx balanced plug from 846' to surface. Cement to surface.
