If the well is a commercially viable well, we will further reclaim the disturbed surface area to the smallest extent possible to adequately operate the well. If the well is not commercially viable, the well will be plugged and the surface will be reclaimed. Therefore, some of the corrective actions have not been finalized. Edge will continue to inform COGCC of the status of the project.
