To date, all flowlines have been tested, flushed and are ready for abandonment, or are abandoned except for the gas gathering line owned by Smith Energy. Soils have been sampled and all results have been submitted to the COGCC for review.

Remaining work to be completed: Apply gypsum to inorganically impacted soil and place below root zone, cover with clean soil and add organic material if available and re-seed. This work is scheduled to be completed starting the week of January 10th.
