In accordance with COGCC Rule 911, this form serves as notification for decommissioning and/or abandonment of the production facility or the off-location wellhead and flowline. The ground and sub-surfaces will be visually inspected for hydrocarbon impacts during equipment decommissioning. Field observations and photo documentation will be recorded in a field inspection form for submittal to the COGCC.

Soil samples will be collected below and/or adjacent to applicable facility equipment, as defined in the Rule 911.a(4) guidance document (1/4/21), for field screening purposes. Discrete soil samples will be collected for laboratory analysis either in any area of observed hydrocarbon impacts, or in the sample locations designated by the COGCC. GPS data will be collected for all soil sample locations. Soil samples will be submitted for laboratory analysis of BTEX, naphthalene, total petroleum hydrocarbons (TPH C6-C36), 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB by EPA Methods 8260B and 8015. Additionally, soil sample(s) will be collected in the area most likely to be impacted by produced water to confirm soil suitability for reclamation. The sample(s) will be submitted for laboratory analysis of electrical conductivity (EC), pH, sodium adsorption ratio (SAR), and boron by saturated paste and hot water soluble extraction methods. Refer to the Proposed Sample Location Map.

If groundwater is encountered during decommissioning and/or abandonment activities, a grab sample will be collected as soon as practical. If contaminated soil is in contact with groundwater or if free product/hydrocarbon sheen are observed, the release will be reported in accordance with Rule 912.b. Groundwater samples will be submitted for laboratory analysis of BTEX, naphthalene, 1,2,4-trimethylbenzene, and 1,3,5-trimethylbenzene by EPA Method 8260.

An assessment will be conducted during the removal of this off-location flowline (estimated to be 1,460 feet in length), with an emphasis in the areas where the flowline is in close proximity to sensitive areas, such as drainage/surface water crossings, High Priority Habitats, and FWS wetlands. The flowline and adjacent sub-surface will be inspected for any visual and olfactory indicators of potential failure and hydrocarbon impacts. Soils will be field screened below the flowline and if suspected impacts are observed, a soil sample will be submitted for laboratory analysis of BTEX, naphthalene, 1,2,4-TMB, 1,3,5-TMB, and TPH (C6-C36) by EPA Methods 8260B and 8015. GPS data and photo documentation will be recorded for each inspection/sample location. A sample location figure will be provided in the Supplemental Form 27.

On October 21, 2021, two background samples (BKG01) were collected from native material topographically up-gradient of the wellhead location and submitted for analysis of pH. Analytical results indicated that pH was in compliance with the applicable Table 915-1 standards in native material.

No soil was removed from the location during wellhead closure activities and removal of the associated flowline.

REMEDATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Provide a brief narrative description including: technical justification, schedule for implementation, estimated time to attain NFA status, plus plans and specifications for the selected remedial action technology.

Soil encountered adjacent to and surrounding the wellhead and below the flowline was visually inspected and field screened for VOC concentrations using a PID. In addition, field screening samples were collected, and inspections conducted along the flowline with an emphasis on areas in close proximity to sensitive areas. Per the approved proposed soil sampling plan, two soil samples were collected at approximately 3 feet and 6 feet bgs from undisturbed areas most likely to be impacted by oil and gas operations located adjacent to and below production infrastructure. Soil samples FLR01 and WH01 were submitted for lab analysis of the COGCC Table 915-1 Organic Compounds in Soil, TPH(C6-C36), pH, EC, SAR, boron and PAHs. Soil samples FL01-02 and FL01-04 were submitted for lab analysis of the BTEXN, TMBs, and TPH(C6-C36). Analytical results indicated that constituent conc. were in compliance of the regulatory standards, except for pH in sample WH01. Two background samples (BKG01) were collected from native material up-gradient of the wellhead location and submitted for analysis of pH. Analytical results indicated that pH was in compliance with applicable Table 915-1 standard in native material. During decommissioning activities, groundwater was encountered at the wellhead and below the flowline. Consequently, two samples GW01 and GW02 were collected from the wellhead excavation and at FL01-02, respectively, and submitted for analysis of BTEX, naphthalene, 1,2,4-TMB, 1,3,5-TMB. Lab results indicated that the samples were in compliance with the applicable COGCC Table 915-1 Groundwater Standards. Analytical results are summarized in Tables 1-4, and GPS coordinates and field screened VOC concentrations are summarized in Table 5. Field screening and lab sample locations collected at the wellhead and along the flowline are shown on Figures 1 and 2. The lab report is included as Attachment A and decommissioning field notes and photo log are included as Attachment B.

OPERATOR COMMENT

Analytical results indicated that constituent concentrations in sample WH01 @ 6' were in compliance with COGCC Table 915-1 standards, with exception to the pH value. Based on the absence of other indicators that a spill or release occurred, such as hydrocarbon detections or elevated EC and SAR in soil, the pH result at this location is not associated with E&P activities. As such, PDC requests that pH not be considered a Table 915-1 contaminant of concern at this location and is requesting a No Further Action (NFA) determination for the Hall 28-5 wellhead.
