A compromised aboveground section of a produced water dumpline resulted in approximately 3 bbls of oil and 2 bbls of produced water being released to the ground surface. The line will be repaired and the impacted soil will be removed. The release was contained to the pad surface. Confirmation soil samples will be collected for COGCC Table 915-1 TPH (C6-C36), organics in soil, inorganics, and a source waste characterization sample for metals will be collected. Background samples for inorganic and/or metals comparison will be collected, as needed. The release did not occur within CPW high priority habitat.
