INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

This form has been prepared to summarize assessment activities conducted during the plugging and abandonment of the State 30-16 wellhead and the permanent removal of the associated off-location flowline. Assessment activities began on June 30, 2021. Soil assessment activities were conducted in accordance with COGCC Rule 911.a. A photo log is attached.

On August 17, 2021, five soil vapor points (SVPs) were installed in the vicinity of the State 30-16 wellhead. On August 20, 2021, the soil vapor points (SVPs) were screened using a GEM 5000 and field results indicated the presence of methane. Samples were collected from SVP03 and submitted to Dolan Integration Group (DIG) for gas composition and isotopic analysis. On August 25, 2021, laboratory analytical results for the SVP samples collected on August 20, 2021, indicated the presence of thermogenic methane as reported to the COGCC in the Form 19 Initial dated August 26, 2021 (Document No. 402792735). The SVP locations are illustrated on Figure 1.

On August 17, 2021, soil samples were collected from the wellhead and flowline excavation, and separator riser. The samples were field screened for total volatile organic compounds using a photoionization detector (PID). Based on PID readings at the flowline and separator riser, no soil samples were submitted for laboratory analysis. Based on PID readings from the base of the wellhead excavation, one sample was submitted for analysis. Analytical results indicated soil was in full compliance with Table 915-1 standards at the extent of excavation. Therefore, further excavation was not warranted. The wellhead excavation and flowline are depicted on Figure 1 and Figure 2, respectively. The soil sample results and PID readings are summarized in Table 1 and Table 2, respectively, and the laboratory report is attached.
