COMMENTS:

TEP Rocky Mountain LLC (TEP) is reporting that the bradenhead on the RMV 28-27 well has been connected to an enclosed combustor as part of a Pressure Management Plan. On July 6, 2021, the RMV 28-27 well had a bradenhead pressure of 150 psi. TEP performed a blowdown test and submitted the test results, via a Form 17, on July 7, 2021. A copy of the Form 17 is included in the "Related Forms" section. TEP monitored the bradenhead pressure after performing the test and determined that the bradenhead pressure continued to build and sustain pressures above the threshold pressure of 88 psi. Due to the sales line pressures approaching or exceeding the 88 psi bradenhead threshold pressure, connecting the bradenhead to the enclosed combustor was our only viable option to manage the bradenhead pressure and maintain a pressure below the threshold. After further diagnostic testing and communications with the COGCC, a potential integrity issue with the production casing may have been identified. A Form 4 (Doc# 402766831) detailing the pending casing repair procedure has been submitted and approved by the COGCC. On December 7, 2021, TEP connected the bradenhead to the enclosed combustor after experiencing delays due to parts and crew availability. A diagram depicting the bradenhead connection to the enclosed combustor is attached. If the pending workover operations identify and correct an integrity issue with the production casing, the bradenhead may be disconnected from the combustor as part of a revised Pressure Management Plan.

4. At least once a year shut in bradenhead for 7 days or until the pressure reaches the bradenhead threshold and perform a bradenhead test. Report results on a Form 17, as specified in Rule 420 or other Director approved submittal method.
5. Comply with any CDPHE, Air Pollution Control Division rules or requirements for all atmospheric discharges.
6. Any liquids blown down are to be collected, stored, handled, and treated or disposed as E&P waste per COGCC's 900 series rules.
7. At least one valve is required to monitor pressure and sample flow from the bradenhead.
