PURPOSE: Plug and abandon uneconomic oil production from the Third Dakota sand through perforations from 5172-78, 5191-92, and 5194-95½ KB in D. Meier #1. Plug the well by placing in the 5½" casing a sand plug from TD (5214 KB) to 5200 and dump bailing a cement plug (8 sack) from 5200 to 5117. Pull the free 5½" casing above 4300 and fill the hole with mud-laden fluid. Dump bail in the bottom of the 10-3/4" surface casing a 15-sack cement plug from 303 to 272. Place a 10-sack cement plug in the top of the surface casing. Top of the surface casing plug is to be below soil cultivation depths. September 28, 1970, is the estimated starting date.
