Well was spudded on 11/17/78. After setting casing, well was drilled to total depth of 5313' and electric logs run. Three drill stem tests were run in "J" Sand to evaluate shows. The results of all proved negative, so well was plugged & abandoned as follows:

- 25 sacks cement plug from 170' to 220'.
- 5 sacks cement plug from surface to 10'.
- Welded cap on surface casing

Hole was filled with heavy mud.
