Conducted field visit to property on November 11, 2021 to discuss Complaint Report, Complainant's concerns, water supply, water rationing, nearby oil and gas activity, and planned future activity. Field Inspection conducted of adjacent well pad the same day (doc #699700277). Conducted follow-up visit with water sampling on November 17, 2021, no hydrocarbon sheens, staining, discoloration, or odor were observed in water sample. Analytical results received December 15, 2021 serve as baseline water quality sample. Analytical results were compliant with COGCC Table 915-1.
