The above described well was drilled to a total depth of 4942' KB and did not encounter  
 any commercial quantities of oil or gas. An electric log was run to the total depth  
 and the well was plugged on September 1, 1955, in the following manner:

Plug #1, 4890' to 4758' - 40 sax - covering the D and J Sands.

Plug #2, 101' (base of surface pipe) - 15 sax.

Plug #3, 5 sax in the top of the surface casing.

The surface casing was used 8 5/8 landed at 101' (KB), with 65 sax of cement.

The hole was full of drilling mud having a weight of 10 #/gal. and a 55 sec. viscosity.

Two copies of the electric log will be forwarded as soon as they are received.
