On Monday 1/10/2022 at approximately 0900, I, Inspector Scott Ramsey, conducted a routine inspection at Caerus C18E, at Location # 324026 in Garfield county Colorado.

While there, I observed normal production operations. All meters have been calibrated on location within the past year. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management Area and 411 water protection. Operator (Caerus) has provided documentation of their Best Management Practices for Sediment Tracking Controls.
