Additional confirmation soil samples will be collected for delineation and remediation confirmation purposes. Assessment activities will be directed by field personnel who will characterize the soil using visual and olfactory observations and field screen soil samples for volatile organic compounds using a photoionization detector (PID). The attached ROWC details the recommended/planned source removal activities. Based on the analytical results of the initial characterization sampling, Caerus is requesting a reduced analyte suite of barium, boron, SAR, EC, TPH, benzene, toluene, ethylbenzene, total xylenes, 1,2,4- trimethylbenzene, 1,3,5 trimethylbenzene, 1-methylnaphthalene, 2-methylnaphthalene, naphthalene, and fluorene.
