Operator Comment: In an attempt to respond to concerns and the corrective action from Inspector De Paolo regarding an "insufficient tracking BMP" at the entrance to the location (Inspection #699804078), TEP brought in additional gravel on 1/31/22 and placed it at the entrance to the location to help minimize the amount of tracking from the pad. The additional gravel was delivered and spread on the pad entrance at approximately 12:30 p.m. on Monday (1/31/22). Inspector Depaolo re-inspected the site at approximately 2:27 p.m. -- approximately one hour after the

gravel was delivered to the location and prior to TEP being able to clean up mud and gravel that was tracked by the dump trucks that hauled the rock. TEP cleaned up tracking from the dump truck on 2/01/22. Pictures of the area after being cleaned up are attached. Due to the corrective action stating that the tracking BMP was insufficient, TEP agreed to put more rock at the entrance. The extra tracking that was caused by placing more rock at the entrance (in response to COGCC's corrective actions) has been cleaned up. As noted on the large sign hanging on the gate to the pad entrance, NO vehicle traffic is allowed on the pad during extreme muddy conditions such as is common during the spring time melting conditions, after storm events, etc.. TEP continues to restrict all traffic / access during extreme muddy condition.
