SES will collect one (1) soil sample from beneath the separator, production tanks and two (2) ( one sidewall and one floor) at the partially buried water tanks. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. All samples collected will be analyzed by a certified laboratory using approved COGCC laboratory analysis methods.

Visual inspection of the location and flowlines will occur during abandonment activities; flowlines will be removed at the time the wellheads (Wattenberg Drilling Fund Well #3 & 4 will be abandoned). Field personnel will field screen all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling is required. The COGCC Tank Battery and Flowline Closure Checklist will be utilized and filled out during the abandonment process. A photolog will be submitted on the subsequent Form 27.
