### INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to COGCC Rule 911 a site investigation will be conducted pertaining to the HSR-CHARLTON 08-20 wellhead cut and cap and flowline removal. Approximately 80' of flowline will be removed. The COGCC will be updated in a supplemental Form 27 if a portion of the flowline is abandoned-in-place due to field constraints. The wellhead will be cut and capped per COGCC rules. The Flowline Pre-Abandonment Notice Document number is included under Related Forms.

Seven grab soil samples were collected for analysis by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron.

The source was delineated through an environmental site assessment. An excavation to remove impacted soil will be scheduled prior to June 1, 2022. Noble proposed an amended Table 915-1 analysis plan to include TPH C6-36, organics, and barium.
