 On Wednesday 2/9/22 at approximately 11:00 hours, I, Inspector Corey De Paolo, Conducted a follow up inspection at TEP ROCKY MOUNTAIN LLC BARRETT ET AL-66S96W /35SESE, Location #334743 in Garfield County Colorado.  
 Refer to document #699803895 inspection conducted on 12/20/21. All previous corrective actions have been completed. While there, I observed normal production operations.  
 During this inspection the following compliance issues were observed:

- 1) Vent pipe on tank open ended with a corrective action date of 2/17/22.
- 2) Location lacks stabilization. Insufficient tracking BMP at entrance to location with a corrective action date of 2/25/22.

- Location is located in a high priority habitat area. Additionally the location is located on the edge of a 411a surface water intermediate buffer zone. All drainages contribute to the Colorado River.

A follow up on this site inspection needs to be conducted to ensure the Compliance issues have been corrected to comply with COGCC rules.
