Please see the attached Spill Investigation Site Diagram for proposed spill investigation points. These were selected to characterize the approximate spill areas from the reported spills. It should be noted that the spill referenced by Document 2524363 is estimated to cover the size of the working surface, approximately 90,000 square feet. The proposed investigation points associated with the other four releases will also be used to characterize this release. Caerus will investigate each identified location at two depths: between six (6) and 12 inches below ground surface (bgs), and between 24 and 30 inches bgs. Each depth interval will be field-screened with visual and olfactory observations and a photo-ionization detector (PID) to identify potentially impacted soil. Investigated soil will also be photographed to document presence/absence of soil staining. Continued in Operator Comments.
