It is proposed to kill the subject well with water and plug and abandon as follows:

Set 150' regular cement plug in 4 1/2" O.D., 11.6# casing from 5750' to 5900' RB to cover perforations from 5782' to 5882'. Set 50' cement plug from 4760' to 4810' after cutting 4 1/2" O.D., casing at 4785'. Set 30' cement plug from 400 to 450' in 7 5/8" O.D., surface casing set at 429'. Set 6' cement plug in top of surface casing with 4" by 10' marker, 6' cemented in top of surface casing.
