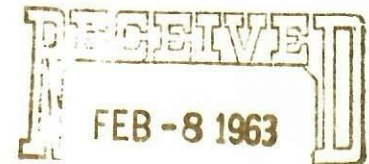

Dear Mr. Morrell:

You will recall our recent telephone conversation regarding the change of operators for the Canadian River and Tow Creek properties. Accordingly, we are enclosing your Form 10 for the following wells: Bradley No. 4, State, No. 2, State No. 5, all located at Tow Creek; and the Blevins "A" 1, Blevins "A" 2 and Blevins "B" 6 at Canadian River.

We are also enclosing your Form 4 for the State No. 3 well at Tow Creek. You will recall that this well is temporarily shut-in and needs remedial work.

It should be further noted that the following wells are now shut-in since they are uneconomic to produce:
Tow Creek: State No. 1, Bradley #2, 3, & 5;
Canadian River: Blevins "A" 3, "A" 4, "A" 5, "A" 7, "A" 8, "B" 2, "B" 3, "B" 5, Texas Gov't #1, and Texas State #1.

SEP - 7 1982

- 7/14/82 Tried to move on to well and rig fell out of site. Got it pulled out. Had Sessions haul gravel pad to back rig on to location.
- 7/18/82 Got pad built and move in and rig up. Packer was stuck in hole. Got it loose and pulled out of hole. Layed down 5 joints with paraffin in them. RIH with scrapper to 2030'.
- 7/19/82 Circulate hole with 3% KCL. POH. Rig up OWP and run Gamma, Bond and Collar log. Perf at 1967½ to 1975½. Set bridge plug at 1992 as casing looked bad at 1995'. Plug back T.D. at 1987' with 1 sack cement set on top of plug. Run in hole with packer and set at 1980' and test tubing and packer. Pull up 1930' and test backside. Tubing tested to 3000# on inside and bridge plug. Casing did not hold. Unloader was leaking on packer. Shut in.
- 7/20/82 POH and check packer and replace unloader. RIH and still bad leak. Tested every 5 stands and found pin hole in tubing. Replace and RIH and tested okay. Swab down and acidize well. Had slight amount of oil show. Did frac job. Blow back good and recovering water. Left flowing all night. Trace of oil with water.
- 7/21/82 Still kicking small amount of water and gas and trace of oil. Release packer and POH. RIH with hydrostatic baler and found sand covering half of perfs. POH and go back with mud anchor, 4' perf nipple and seating nipple. Seating nipple at 1950'. Start swabbing. Pulling mud and KCL water and a skim of oil. Small amount of gas.
- 7/22/82 Casing 380# tubing 360#. Unload mud and water and skim of oil and gas. Flowed for 45 minutes. Swab well. Oil increasing. Rig down and wait on RMNG crew to lay line to inject gas to unload well.
