Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS which reflects the reference area. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed.	CostaR	02/15/2022
