Comment: The undesirable vegetation at the location has been mowed since previous inspection. Drone aerial photo shows an impacted area along the former flowline. This impacted area needs to be reclaimed and soils should be sampled at this area. There are multiple berms along the former road that need to be leveled and reclaimed. It is unknown if additional reseeding was performed. The location consists mostly of undesirable weeds which will require ongoing weed control.
