Comment: COGCC inspector met with Top contract personnel on location (Amen Oilfield); crews were in the process of removing historically impacted soils/ groundwater and production equipment from location. An open excavation at the PA well exposed flowlines; (2) 1" poly and (1) 2" CS flowline cut ends were observed E-W walls of the excavation. The Tanaka Bros #1 well has been plugged and abandoned; COGCC form 42 notice of start of plugging operations doc #402881829 was received on 11/29/2021. The facility is being decommissioned; tanks/ equipment are being removed. The on location flowlines are scheduled to be removed (wellhead, gas supply, dump/ process lines). COGCC form 42 flowline pre-abandonment 30 day notice doc #402860828 was received 11/03/2021. Also, (1) off location domestic tap flowline (1" yellow poly line) was observed exposed in the wellhead excavation. Per conversation with the contract lead, this flowline is scheduled to be abandoned in place. The flowline runs approximately 400' southwest to a large agricultural/ equipment building. The riser and tie in at the building has been isolated/ removed and buried below grade (confirmed via inspection w/ Amen personnel). Excavation and remediation work is in progress.
