Comment:

A culvert associated with the location entrance is not in use/damaged, presents a safety hazard and is debris. It appears that country road snow removal operations may have caused the damage. Refer to the attached inspection photos.

The location is being managed and appears to be progressing towards final reclamation standards. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management. Operator shall submit a Form 4 Final Reclamation Complete notice when the location meets Rule 1004 standards. COGCC may conduct inspections prior to receiving said notice to ensure compliance with Rule 1004.

Corrective Action: Comply with Rule 1004.a to remove the culvert.
