A mechanical integrity test was completed on 4/27/2018, and was submitted to the COGCC. The well is closed at the atmosphere via a wellhead secured and shut in by a valve, as well as a CIBP set at 1585'. This well is considered to be a good candidate for recompletion, and a sundry for recompletion has been approved by the COGCC. ENR plans to recomplete this well as soon as logistically possible. In the meantime, Evergreen Natural Resources LLC is requesting continued temporarily abandoned status on the Bucksnot 41-35 well as it awaits recompletion operations to bring the well back to a producing status.
