Inspection #696203226 observed that the western/southern/eastern interim areas are not progressing towards 1003 standards. Inspection required Operator to comply with Rule 606.c and 1003 rules.

Limited visibility due to snow cover prevented the Reclamation Specialist from conducting an accurate assessment of the Reclamation Areas; however, no resolution has been submitted from Operator stating CA has been addressed; corrective action will remain applicable. A followup inspection will be conducted to determine compliance with 1003 rules.
