### INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A site investigation will be conducted pursuant to COGCC Rule 911 at the TREBOR T5N-R64W-S14 L03 Tank Battery location. Laboratory analytical indicated a historical release occurred at the Trebor B 14-5 decommissioned tank battery location. One soil sample exceeded Table 915-1 groundwater protection screening levels for 1,2,4-trimethylbenzene, 1-methylnaphthalene, and naphthalene.

Four grab confirmation soil samples were collected and were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron.

If groundwater is encountered during the site investigation monitoring wells will be set at each bore hole location. Groundwater samples will be collected for analysis of BTEX, naphthalene, 1,2,4-trimethylbenzene, 1,3,5-trimethylbenzene, and inorganic parameters.
