Set 220' of 10 3/4" surface casing with 75 sacks of cement.  
Lost circulation at 650' - filled with 85 sacks of cement. Hole reamed to 820  
feet and set 8 3/4" pipe.  
Tops: Niobrara - 3930', Ft. Hayes 4215'; Greenhorn 4490'; "D" - 4737'; "G" - 4792';  
"J" 4846' - Total Depth Driller 5160'; Schlumberger Log 5157'.  
No shows of oil or gas in any sands.  
Well plugged and abandoned December 3, 1951 in following manner:  
Filled hole with 11# rotary mud, set wood plug at 820', dumped 20 sacks of cement  
on top of plug; Set wood plug 40' below bottom of cellar, dumped 20 sacks of cement  
on top of plug. Set regulation marker in 3 feet of cement.
