This form is being submitted to comply with COGCC Rule 911.a.(4). The form serves as the initial notification to decommission a portion of the Bull Fork Water Transfer System (off-location produced water pipeline).

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Caerus will visually inspect and field screen the base and sidewalls of each excavation associated with the produced water transfer system abandonment. The system abandonment, as seen on the attached map, will include the main pipeline and individual legs going to each well pad the pipeline services. If field screening indicates impacts to soil in any of these locations, the sample exhibiting the highest degree of impacts based on field screening will be collected from the associated area and submitted for laboratory analysis of the full list of constituents in COGCC Table 915-1. Any impacted soil will be segregated, stockpiled onsite, and the extent of impacts will be investigated through additional excavation and confirmation soil sampling. Continued in "Additional Investigative Actions" below.

Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

Groundwater is not expected to be encountered. If groundwater is encountered during investigation activities, the COGCC will be notified, and a representative sample will be collected and submitted for laboratory analysis for constituents listed in COGCC Table 915-1.
