Areas below the separator, meter and flowline/water lines will be field screened with a PID and/or Petroflag. If concentrations do not indicate a hydrocarbon presence, Vision is requesting a reduced analyte list consisting of TPH/BTEX and Inorganics (SAR/EC/pH).
