Comment

At time of inspection Master valve, and both casing valves were in the open position. All flowline valves were closed. Bradenhead valve is closed. During inspection master valve, and both casing valves were put in the close position. Both tanks on location contain production fluids.

Because P3 is not actively managing any of its Colorado Wells or Locations there is a direct threat to public health, safety and welfare, including the environment and wildlife resources. Therefore, the COGCC will undertake steps to, at a minimum, shut-in all of P3's wells and lock-out/tag-out P3's flowlines. COGCC may take additional actions to protect public health, safety and welfare, including the environment and wildlife resources, without providing advanced notice.
