Schneider Energy Services intends to plug and abandon the Wattenberg Drilling Fund LLP 3, API # 05-123-32924, and Wattenberg Drilling Fund LLP 4, API # 05-123-32927. The flowline segments associated with these wells will be removed from the ground. The area will be field screened in accordance with the site decommissioning Form 27, Document # 402948608.

The Weld County Drilling Fund LLP 1, API # 05-123-32925, was plugged and abandoned on 6/28/2019, Form 6-S Document # 402092373. The associated flowline was abandoned on 7/2/2019, Document # 402095426. The Weld County Drilling Fund LLP 2, API # 05-123-32923, was plugged and abandoned on 6/28/2019, Form 6-S Document # 402093509. The associated flowline was abandoned on 7/2/2019, Document # 402095452. The attached shapefile has been updated to reflect its abandoned status.

All flowline risers will be removed when the production facility is closed.

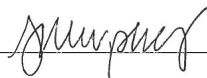
