Limited visibility due to snow cover prevented Reclamation Specialist from accurately assessing the reclamation of the Location. Based on the vegetation that was observable, Location appears to be progressing towards 1004 standards; however, there are areas on the south east end of the Location where perennial vegetative establishment is not as evident- these areas may require addition reclamation. See photo documentation attached.

A follow-up inspection will be conducted at a future growing season to determine compliance with 1004 Rules.
