KPK will visually inspect and screen the area around the wellhead in all four directions of the subsoil during cut and cap operations. KPK will submit a sample from the area exhibiting the highest degree of impact, or in the absence of impacts, KPK will submit a sample from the excavation adjacent to the well pursuant to Rule 911.A.(4) guidance. This Form 27 will be updated with a sampling plan if contamination is observed, and an additional appropriate number of samples are needed to be collected for the excavation size.
