Operator Comment: Kinder Morgan EHS Supervisor Mike Hannigan contacted COGCC Environmental Protection Specialist Jim Hughes via telephone on 2/28/2020 to discuss the applicability of Rule 906.c. to the interim reclamation area of the YB-1 well location. Jim's preference is to address the issue through the FIRR process rather than through a Site Remediation Workplan (Form 27). Soil samples will be collected and analyzed for EC, SAR and pH to

determine level of impact and which soil amendments are required for remediation and successful reclamation of the area of the YB-1 location noted in the FIR. Initial soil samples have been collected and soil amendments have been ordered. Additional soil sample collection and laboratory analysis will take place when weather conditions allow.

COGCC Decision: Approved pending re-inspection

COGCC Representative: If soil sampling reveals impacts related to oil and gas activities at this site, a Form 27 Site Investigation and Remediation Workplan shall be submitted by the operator.
