## INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A partially buried produced water vessel (PWV) was removed from the Vanthuyne 42-34 location on March 8, 2018. Impacted soil and groundwater were not encountered in the PWV excavation. A liner was not present beneath the PWV at this site. The PWV at this facility has been permanently removed. Soil and groundwater samples collected from the excavation were submitted for laboratory analysis, to determine if a release occurred. The general site layout, sample locations, and PWV excavation dimensions are depicted on the Sample Location Map provided as Figure 1.

## PROPOSED SAMPLING PLAN

### Proposed Soil Sampling

☒ Will soil samples be collected as part of this investigation? ( Number, type (grab/composite), analyses, and locations of samples ):

On March 8, 2018, following removal of the PWV, soil samples were collected from the sidewalls of the excavation. The soil samples were field-screened for volatile organic compounds using a photoionization detector (PID). Soil sample N01@4' was submitted for laboratory analysis of benzene, toluene, ethylbenzene, and total xylenes (BTEX), total petroleum hydrocarbons (TPH) – gasoline range organics (GRO) by EPA Method 8260C, TPH diesel and oil range organics (DRO and ORO) by EPA Method 8015, pH, and electrical conductivity (EC). Laboratory analytical results for soil sample N01@4' indicate that BTEX, TPH, pH, and EC concentrations and levels were in full compliance with COGCC Table 910-1 allowable levels. The soil sample analytical results are summarized in Table 1, and the laboratory analytical report is attached.

### Proposed Groundwater Sampling

Groundwater was encountered in the PWV excavation at approximately 5 feet below ground surface (bgs). One groundwater sample (GW01) was collected from the excavation and submitted for laboratory analysis of BTEX. Laboratory analytical results indicated that the groundwater sample was in full compliance with COGCC Table 910-1 allowable levels for BTEX. The groundwater sampling results are summarized in Table 2 and the laboratory analytical report is attached.

Laboratory results indicate that soil sample N01 @4' and groundwater sample GW01 were in full compliance with COGCC Table 910-1 allowable levels, therefore, no soils were removed. The excavation area was backfilled and contoured to match pre-existing site conditions.

Laboratory results indicate that soil sample concentrations were in compliance with COGCC allowable levels. Groundwater was encountered in the PWV excavation. Groundwater sample concentrations were in compliance with COGCC allowable levels. Based on the analytical data presented herein, assessment is complete at this site and no further activities are required. Upon COGCC approval of the Initial Form 27, Kerr-McGee will submit a Supplemental Form 27 request for a No Further Action (NFA) determination for this site.
