## INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Five discreet confirmation soil samples were collected on 3/20/19 (4 wall and 1 base) from the produced water tank excavation. The samples from the base, south wall, and north wall were analyzed for benzene, toluene, ethylbenzene, total xylenes (BTEX), gasoline range organics (GRO), and diesel range organics (DRO). In addition, the north wall sample was analyzed for pH, Electrical Conductivity (EC), and Sodium Absorption Ratio (SAR). Concentrations of BTEX, GRO, DRO were detected above COGCC Table 910-1 in the base sample and the south side wall sample. The results for pH, EC, and SAR were reported below Table 910-1. Five test pits were excavated to determine the extent of petroleum hydrocarbon impacts. Samples were collected from each test pit location and analyzed for GRO and DRO. The sample for Test Pit #2 reported GRO above Table 910-1. Samples from the other four test pits were reported at, or below the laboratory reporting limit. Impacted soil associated with the produced water pit and associated flow lines release will be addressed under a separate Form 27. See the attached laboratory report, soil analytical table, and Figure 3.
