On Wednesday 3/2/22 at approximately 13:30 hours, I, Inspector Corey De Paolo, Conducted a storm water inspection at CAERUS PICEANCE LLC MURRAY-68S96W /1SESW, Location #334086 in Garfield County Colorado. While there, I spoke to Adam Roll he stated that a street sweeper would be arriving later that day. During this inspection the following compliance issues were observed:

1) Location lacks stabilization. Insufficient tracking BMP at entrance to location. Sediment has been transported on to County road 306 for approximately 100 yards.

- Location is located in a high priority habitat area.

A follow up on this site inspection needs to be conducted to ensure the Compliance issues have been corrected to comply with COGCC rules. This is a summary of inspection report.
