<p>At time of inspection all flowline valves, and master valve were in the close position. 1 flowline valve is seized in the open position.</p> <p>Because P3 is not actively managing any of its Colorado Wells or Locations there is a direct threat to public health, safety and welfare, including the environment and wildlife resources. Therefore, the COGCC will undertake steps to, at a minimum, shut-in all of P3's wells and lock-out/tag-out P3's flowlines.
