While there, I observed normal production operations.

During this inspection the following compliance issues were observed:

- 1) Location lacks stabilization. Insufficient tracking BMP at entrance to location with a corrective action date of 3/29/22.

Location is located in a high priority habitat area.

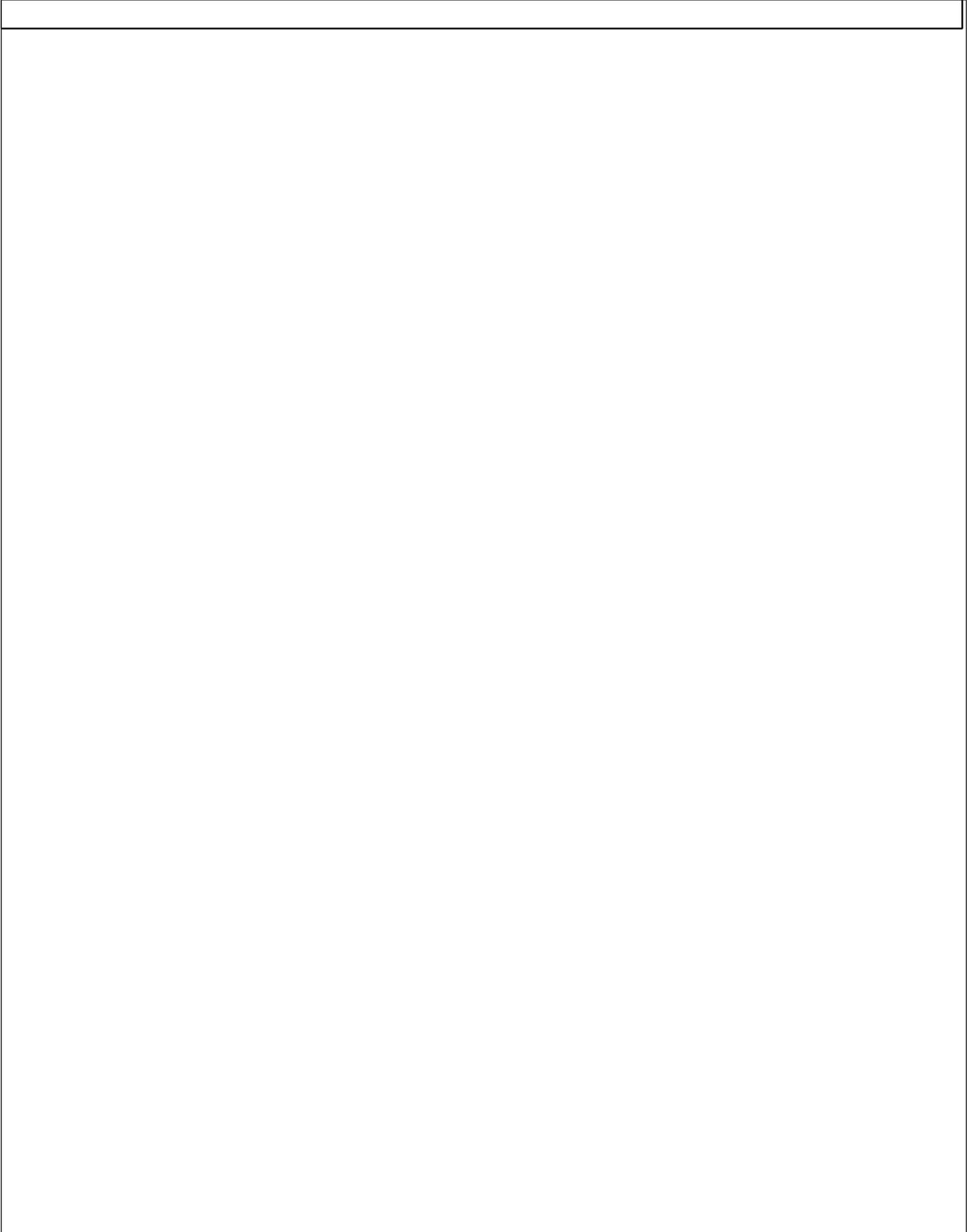
