Inspection #696202262 observed various debris (pipe, wood, etc...) and utility equipment remaining on the Location. Inspection required Operator to comply with Rule 1004.a.

It was observed in this inspection that the pipe/wood debris and equipment have been removed. Corrective action has been addressed.

Limited visibility due to snow cover prevented reclamation specialist from conducting an accurate assessment of the Location; perennial vegetation was not as evident within central areas of the Location covered with snow and may require additional work.

Continue to monitor and manage Location until site receives a passing final inspection. Conduct additional work as necessary to ensure site progresses towards 1004 standards.
