<p>At time of inspection all valves were in the close position. Master valve is in the close position. Bradenhead is not plumbed to surface. Open top tank is nearly full, any precipitation may cause it to overflow.</p> <p>Because P3 is not actively managing any of its Colorado Wells or Locations there is a direct threat to public health, safety and welfare, including the environment and wildlife resources. Therefore, the COGCC will undertake steps to, at a minimum, shut-in all of P3's wells and lock-out/tag-out P3's flowlines.
