TEP has implemented BMPs that are controlling and managing the flow of storm water (snow melt) runoff at this location and erosion is being minimized (not eliminated). The cut-slope at this location is stable, and the BMPs implemented at this location comply with Rule 1000.f.(2) and are designed to minimize (not eliminate) erosion, the transport of sediment offsite, and site degradation.
