A site investigation will be conducted pursuant to COGCC Rule 911 at the RUBIX JOHNSON QC T6N-R64W-S32 L01 Tank Battery location.

Grab confirmation soil samples will be collected from the three (3) produced water vessels excavation, two (2) beneath the ground oil tanks, and at the two (2) separators. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. All samples collected will be analyzed by a certified laboratory using approved COGCC laboratory analysis methods.

The COGCC Tank Battery and Produced Water Vessel Closure Checklists will be utilized and filled out during the abandonment process. A photolog will be submitted on the Subsequent Form 27.
